Exhibitor Application & Agreement

2017 Andersontown Powwow

September 9th & 10th, 2017

- 1. A booth fee of \$95.00, <u>must</u> be sent with the application and postmarked no later than August 15, 2017 in order to reserve your booth space.
- 2. The Exhibitor shall not move out display before the official closing time which is 4:00 p.m. September 10th, 2017.
- 3. Merchandise must be authentic for the period and made in the USA. All tables covered to the ground level. The Exhibitor shall provide their own tables/chairs and covered table skirting.
- 4. The Exhibitor shall secure **appropriate license(s)** and/or permit(s) required by the various government agencies prior to the event.
- 5. Exhibitors may not display or sell any items that contain materials derived from animals which are considered endangered or might otherwise be considered in violation of local, state, and/or Federal laws. The DNR will make inspections.
- 6. No walk-ins accepted.
- 7. The Exhibitor shall be responsible for procuring their own insurance coverage for protection against loss, injury or damage to their own or the other person's, arising out of or connected with their use and occupancy of the booth space herein provided for.
- 8. The Powwow will not be liable for the refunds of or any other liabilities whatsoever for the failure to fulfill this contract due to any cause beyond The Powwow's control such as acts of God, public enemy; strikes or statutes or ordinances of any legal authority.
- 9. The Powwow will not be responsible for the safety of the property of the Exhibitor from theft, damage by fire, accident or other causes, unless due to the negligence of The Powwow.
- 10. The Indiana State Fire Marshall requires all Exhibitors to provide an appropriate fire extinguisher in their booth and prohibits smoking in the tents/booths. A representative of the Indiana State Fire Marshal will conduct an on-site inspection and all rules and regulations/rules must be followed.
- 11. Final Approval of this contract is at the discretion of the Andersontown Powwow.
